

1. KEY/FOB/REMOTE REPAIR/REPLACE:

In the event your key/fob/remote that operates your vehicle becomes inoperable, lost, or stolen, the administrator will pay for or reimburse you for an OEM (or like/kind/quality replacement) key/fob/remote.





FRONT WINDSHIELD REPAIR (CHIP/CRACK):

In the event your front windshield incurs damage (chip or crack) caused by a road hazard on a public roadway, you will be reimbursed for repairs of cracks less than 6 inches in length, and/or up to 1.5 inches in diameter, if determined repairable using the administrator's designated glass repair technician's final assessment. Weather related damage is NOT covered.





PAINTLESS DENT REPAIR:

Paintless Dent Repair (PDR) is a metal body repair process that enhances the appearance or removes small dents/dings in metal panels on your vehicle without damaging the painted surface. A trained PDR technician will use this process to repair and/or remove dents/dings of up to 4 inches or less on vertical and horizontal panels. Dents/dings caused by hail damage are NOT covered under the terms and conditions of this agreement.





TIRE AND WHEEL REPAIR/REPLACE:

Tire and wheel benefits are afforded to you only in the event your vehicle incurs damage due to a covered road hazard incident. This is a repair first benefit, meaning Tire Industry Association (TIA) approved repair methods and services will be used to repair your covered tire/wheel. In the event a covered tire/wheel cannot be repaired and/or can no longer hold an airtight seal, it will be replaced in accordance with all of the terms, conditions and limits in the agreement.

The replacement tire/wheel may be new, remanufactured, non-original equipment, manufacturer's parts, or parts of the same like, kind, and quality (LKQ) (when available and as deemed necessary by the administrator) as the tire/wheel being replaced. Additional benefits may be available under this agreement including: companion tire replacement, tire pressure monitoring system replacement, and cost of mounting and balancing.

The product being offered is a service contract and is separate and distinct from any product or service warranty, which may be provided by the manufacturer, importer, or seller.

Coverage may vary by state or lender. Always review and refer to your agreement for complete coverage details.





COSMETIC WHEEL REPAIR:

The administrator will pay the cost to repair minor cosmetic damage to covered wheels with a factory brushed or painted surface. Using TIA standard repair procedures, a service provider and/or repair facility will attempt to remove cosmetic blemishes to a vehicle's covered wheel utilizing professional wheel restoration services. If the cosmetic damage to the covered wheel cannot be repaired through normal cosmetic repair procedures, the covered wheel will NOT be replaced. In the event the designated wheel repair technician determines the cosmetic wheel repair cannot be made within TIA safety standards, it is your responsibility to replace the wheel at your own expense (benefit reimbursement for cosmetic wheel damage is for REPAIR ONLY, and does NOT cover any costs associated with wheel replacement).

INTERIOR REPAIR:

In the event your vehicle incurs minor rips, scratches, cracks, stains, tears (less than 3 inches in length), burns, or punctures (less than the size of a half-dollar) to its interior surfaces, the administrator will either pay for or reimburse you per occurrence towards the cost of repairs. Interior surfaces include: fabric and/or leather seats, dashboard materials, armrests, door panels, headliners, and/or carpeting (floor mats are excluded). This covered service does NOT cover permanent stains to any interior surface(s) that cannot be removed using normal, customary stain removal and/or interior cleaning processes. This covered service will NOT cover the replacement of any interior surface(s), in the event the damage cannot be repaired. Repair will be limited to the final professional judgment of the administrator's interior repair technicians.

When you chose **Stand-alone** you select only the coverage you want. By selecting the Pro Bundle you get all coverage, plus Interior Repair.

ANCILLARY BENEFITS

EMERGENCY ROADSIDE AND TOWING SERVICE:

Every Revolution Protection program includes 24/7 nationwide sign & drive emergency roadside assistance, if your vehicle has experienced a breakdown or vehicle disablement and you need the following:

- Towing
- Jumpstart (cannot jumpstart a HYBRID/EV **Battery**)
- Flat tire change (with your vehicle's inflated spare)
- Fluid Delivery (oil, water, or fuel) cost of fluids not included
- Lock out assistance (entry into passenger compartment only)

RENTAL CAR OR ALTERNATIVE TRANSPORTATION REIMBURSEMENT:

In the event your vehicle is kept overnight for a covered service, you will be eligible for reimbursement towards rental car or alternative transportation expenses. Alternative transportation includes a taxi, car service, rideshare (such as Uber, Lyft, etc.), train fare, or bus fare.

TRIP INTERRUPTION REIMBURSEMENT:

In the event of a breakdown or vehicle disablement resulting in a covered service for your vehicle, you will be eligible for reimbursement towards motel/hotel lodging and restaurant expenses incurred, providing you are in excess of 100 miles from your primary residence.
