RETRO PARTICIPATION

A smart, low-risk entry point in reinsurance. This program allows dealers to share in the underwriting profits of vehicle protection products without the need to own or operate a reinsurance company.

CFC

In a Controlled Foreign Corporation (CFC) program, the dealer principal forms and owns their own reinsurance company, giving them greater control of their F&I profit potential while maximizing tax efficiency.

SUPER CFC

The Super CFC program is a powerful reinsurance structure designed specifically for the largest volume dealerships that threaten the annual premium cap. Dealers will benefit from the retail accounting strategy deferring tax liability.

DEALER OWNED WARRANTY COMPANY

With ARC's Dealer Owned Warranty Corporation (DOWC) program, the dealer principal forms a C-Corporation under state law and becomes the licensed provider and obligor of service contracts. The structure is more complex than a Super CFC, but with that complexity comes greater ownership, flexibility, and long-term earning potential.

NCFC

Non-Controlled Foreign Corporation (NCFC) programs allow dealers to share in underwriting and investment profits through ownership of participating stock in an offshore reinsurance company, without direct control over its operations. This allows dealerships to participate in the profits of F&I products without the responsibility of managing a reinsurance company.
